VI. Department of Children and Families – Reggie Bicha, Secretary

The Department of Children and Families requests the transfer of \$1,416,800 FED in fiscal year 2010-11 from its federal block grant aids appropriation under s. 20.437(2)(md) to the Department of Health Services' federal aid; community aids appropriation under s. 20.435(7)(o) to fund court-ordered kinship care cases that convert to foster care cases as part of the graduated foster care licensing system approved in 2009 Wisconsin Act 28.

The department further requests the transfer of \$3,200,000 FED in fiscal year 2010-11 from its federal block grant aids appropriation under s. 20.437(2)(md) to its federal block grant operations appropriation under s. 20.437(2)(mc) to fund the department's costs related to improving state management of child care operations and the detection and prevention of fraud in the Wisconsin child care subsidy program.

VII. Department of Children and Families – Reggie Bicha, Secretary

Pursuant to s. 9108(7f) of 2009 Wisconsin Act 28, the Department of Children and Families requested approval of its plan to implement a child care quality rating and improvement system under a 14-day passive review process.

Expenditure of American Recovery and Reinvestment Act funds for Temporary Assistance for Needy Families program pursuant to 2009 Wisconsin Act 2, Section 9131(1)(b).

The Department of Administration requested increased expenditure authority of \$29,000,000 PR-S in fiscal year 2009-10 and \$29,000,000 PR-S in fiscal year 2010-11 in the Shared Revenue and Tax Relief's earned income tax credit; temporary assistance for needy families appropriation under s. 20.835(2)(kf) under the 14-day passive review of s. 16.515. The increased expenditure authority will supplement the amount of Temporary Assistance for Needy Families funding for the earned income tax credit authorized under 2009 Wisconsin Act 28.

X. <u>Department of Administration</u> – Dan Schooff, Deputy Secretary

Expenditure of American Recovery and Reinvestment Act funds for expanding broadband telecommunication services pursuant to 2009 Wisconsin Act 2, Section 9131(1)(b).

XI. <u>Department of Administration/Office of Justice Assistance</u> – David Steingraber, Executive Director

The Department of Administration submitted a report as required under Section 9101(12x) of 2009 Wisconsin Act 28 addressing the feasibility and cost of developing a system to collect, transfer and analyze data related to traffic stops under the 14-day passive review process. Section 9101(12x) specifies that system development may not begin prior to approval of the report.

The Office of Justice Assistance requested increased expenditure authority of \$50,600 PR and permanent position authority of 0.60 FTE PR position in fiscal year 2009-10 and \$757,000 PR and 3.14 FTE PR positions in fiscal year 2010-11 in the traffic stop data collection; state appropriation under s. 20.505(6)(kq) under the 14-day passive review of s. 16.515/505(2) to implement the requirements of traffic stop data collection as passed in 2009 Wisconsin Act 28.

Due to an objection from a Committee member, these requests are now before the Committee under s. 13.10.

XII. Department of Corrections – Rick Raemisch, Secretary

The Department of Corrections requests the transfer of \$2,592,500 GPR in fiscal year 2009-10 from its energy costs; energy-related assessments appropriation under s. 20.410(1)(f) to its services for community corrections appropriation under s. 20.410(1)(b). The department also requests the transfer of \$2,909,400 GPR from its corrections contracts and agreements appropriation under s. 20.410(1)(ab), \$70,000 GPR from its pharmacological treatment for certain child sex offenders appropriation under s. 20.410(1)(bm), \$212,000 GPR from its general program operations appropriation under s. 20.410(2)(a), and \$3,067,900 GPR from its energy costs; energy-related assessments appropriation under s. 20.410(1)(f) in fiscal year 2009-10 to its general program operations appropriation under s. 20.410(1)(a). The purpose of the balance transfers is to maintain institutional and community correctional services.
