III. Department of Agriculture, Trade and Consumer Protection – Brad Pfaff, Secretary

The Department of Agriculture, Trade and Consumer Protection requested the creation of a 1.0 FTE PR two-year project position beginning in fiscal year 2019-20 in its industrial hemp appropriation under s. 20.115(7)(gc) under the 14-day passive review of s. 16.505(2).

The Public Commission requested the creation of a 1.0 FTE PR permanent position beginning in fiscal year 2019-20, and \$53,000 PR in fiscal year 2019-20 and \$70,700 PR in ongoing expenditure authority in fiscal year 2020-21 in its general operations assessment appropriation under s. 20.155(1)(g) under the 14-day passive review of ss. 16.505(2) and 16.515.

V. <u>Department of Revenue</u> – Peter Barca, Secretary

The Department of Revenue requested the creation of 15.0 FTE PR permanent positions and the conversion of 8.0 FTE PR project positions to permanent positions beginning in fiscal year 2019-20, and \$1,301,900 PR in fiscal year 2019-20 and \$1,585,900 PR in ongoing expenditure authority in fiscal year 2020-21 in its debt collection appropriation under s. 20.566(1)(h) under the 14-day passive review of ss. 16.505(2) and 16.515. The positions and expenditure authority would expand the operations of the Statewide Debt Collection program.

VI. <u>Department of Revenue</u> – Peter Barca, Secretary

The Department of Revenue requested the creation of 3.0 FTE PR permanent positions and 1.0 FTE PR project position beginning in fiscal year 2019-20, and \$328,700 PR in fiscal year 2019-20 and \$395,800 PR in ongoing expenditure authority in fiscal year 2020-21 in its administration of liquor tax and alcohol beverages enforcement appropriation under s. 20.566(1)(ha) under the 14-day passive review of ss. 16.505(2) and 16.515. The positions and expenditure authority would increase the department's ability to enforce Wisconsin's alcohol beverage laws.

VII. <u>Wisconsin Housing and Economic Development Authority</u> – Joaquin Altoro, Executive Director
