I. Department of Natural Resources

Moved by Senator Darling and seconded by Representative Kaufert to provide \$45,800 SEG in 2003-04 and in 2004-05 from the all-terrain vehicle (ATV) account in the appropriation under s. 20.370(3)(as) to provide additional funding for ATV law enforcement supplies and services.

II. Office of the Commissioner of Insurance

Moved by Senator Darling and seconded by Representative Kaufert to approve the transfer of 1.0 program assistant position and \$39,200 PR annually from the agency's administrative and support services appropriation under s. 20.145(1)(k) to its general program operations appropriation under s. 20.145(1)(g) to reallocate funding and position reductions required under 2003 Wisconsin Act 33 (the 2003-05 biennial budget act).

III. Department of Health and Family Services

Moved by Senator Darling and seconded by Representative Kaufert to: (a) delete \$509,800 GPR and 3.05 GPR positions, beginning in 2003-04, from the appropriation under s. 20.435(2)(bm) that supports the Sand Ridge Secure Treatment Facility; (b) delete \$70,000 GPR annually from the appropriation under s. 20.435(2)(b) that supports the Wisconsin Resource Center; and (c) increase funding to support the state mental health institutes by \$579,800 annually in the appropriation under s. 20.435(2)(a).
